A. FY 2019 Write-Offs from FY 2018 Bad Debts

Each year, LL&P writes off the balances from accounts that have been closed, collection attempted and/or lienied, and that have had no activity since June of the previous year. The current write-off list for 2019 is in the amount of \$2,779.58, which is 0.0325% of Fiscal Year 2018's total electric sales and late fees. When comparing to last year, write-offs decreased by 12.92%.

B. Amendment to LL&P MERS 457 Plan

LL&P currently offers a MERS 457 Plan. Adding the Roth Contribution would be a post-tax modification to our existing plan. This would not cost LL&P anything and would offer employees another option to save for retirement. The City adopted this contribution method in 2016 when their 457 Plan was implemented. If the Board decides to adopt this, it would go to the City Council for final approval.
