A. <u>Fiscal Year 2017 Audit Presentation and Acceptance</u>

Peter Haefner and Matt Smith from Vredeveld Haefner presented and reviewed slides and gave a summary of the audit findings. LL&P received a clean audit which is the highest opinion that can be received.

It was MOVED BY CADWALLADER, SUPPORTED BY SALZWEDEL, to approve the audited financial statement for Fiscal Year 2017.

B. Discussion and Potential Adoption of Economic Development Rate

Mark Beauchamp with USF presented a couple different Economic Development Rate options (5 Year and 3 Year) to the Board last month. At that time, there was a consensus by the Board to table this and asked Donkersloot to talk with City Manager Mike Burns.

Since last month's meeting, Donkersloot had the opportunity to talk with Mike regarding this. Mike is in favor of the LL&P Board adopting one of the two rates that were presented by Mark Beauchamp last month.

After much discussion, the Board decided they were most comfortable with the 3 Year Economic Development Rate.

C. MERS 2018 COLA

At the August Board Meeting, the Board decided to have valuations performed to determine the cost of providing LL&P retires with a 2.50% or a 2.80% Cost of Living Adjustment (COLA).

Donkersloot summarized theses items for the Board to review. There was Board discussion.

It was MOVED BY SALZWEDEL, SUPPORTED BY CADWALLADER, to adopt the 2.50% for a cost of \$78,129 COLA pending City Council's approval.

There are several upcoming projects that require a number of utility poles. Therefore, more poles must be ordered to restock our inventory.

Three quotes were received: Bell Lumber & Pole bid came in at \$11,803, (their quote included a lower quantity of poles to fill their truck); McFarland Cascade quote was \$11,906; Thomasson Lumber was the low bid at \$11,041.30.

It was MOVED BY CADWALLADER, SUPPORTED BY SCHRAUBEN, to approve Thomasson Lumber's quote of \$11,041.30.
